Vadovaudamasis Tarptautinių ir nacionalinių klasifikatorių tvarkymo ir naudojimo valstybės ir žinybiniuose registruose ir valstybės informacinėse sistemoje taisyklių, patvirtintų Lietuvos Respublikos Vyriausybės 2005 m. kovo 3 d. nutarimu Nr. 247 „Dėl Tarptautinių ir nacionalinių klasifikatorių tvarkymo ir naudojimo valstybės ir žinybiniuose registruose ir valstybės informacinėse sistemoje taisyklių patvirtinimo“, 9 ir 10 punktais, siekdamas įgyvendinti Europos Sajungos Statistikos tarnybos rekomendacijas dėl Jungtinių Tautų statistikos komisijos ir Jungtinių Tautų Nusikaltimų prevencijos ir baudžiamosios teisenos komisijos patvirtinto Tarptautinio nusikaltimų klasifikatoriaus statistiniams tikslams (angl. *The International Classification of Crime for Statistical Purposes – ICCS*), pritaikymo nacionalinėms reikmėms ir atsižvelgdamas į darbo grupės, sudarytos Informatikos ir ryšių departamento prie Lietuvos Respublikos vidaus reikalų ministerijos direktorius 2018 m. liepos 10 d. įsakymu Nr. 5V-48 „Dėl darbo grupės sudarymo“, parengtą sąrašą (klasifikatorių), kuriaame Lietuvos Respublikos baudžiamajame kodekse nustatytos nusikalstamos veikos priskirtos atitinkamoms Tarptautinio nusikaltimų klasifikatoriaus kategorijoms:
