The ECRIS Process



Supported by the Criminal Justice Programme of the European Union

• A national (Subject) from one EU Member State detained/convicted in another EU Member State.

European Request Information Capture

- 'Request for' criminal conviction history is sent to the Subject's home Member State.
- Home Member State needs to confidently match the subjects identity to the person record.
- Conviction history released to requesting MS



The Issues



- The detail captured relating to a Subject is used by the receiving MS Central Authority (CA) to complete the relevant search of the criminal conviction history data bases.
- The quality of data being submitted via ECRIS between the Central Authorities is not always of a good standard.
- The home country (CA) needs to establish the subject's identity within the databases.
- Owing to the poor quality of information received, the CA has difficulty in establishing the identity. This maybe because the necessary information to do this, is missing.
- Therefore, the success rate for the exchange of criminal conviction history between the MS is not as high and consistent as it could be.

Other Findings

- The ECRIS project created a universal list of key search criteria requirements for all Member States.
- Research and experience has shown us that each MS has additional unique requirements to successfully search and confirm identity on their data bases.
- The information captured at operational level by Police / Investigators / Prosecutors and the Courts needs to reflect these requirements.

The Solution?

European Request Information Capture



- Ensure that the all the correct search information is obtained by the Police / Investigators / Prosecutors and Courts to send to offenders Home Member State's CA at the start of the judicial process.
- Educate and inform all the operational end users of the benefits this will bring to the ECRIS process if they capture the right information at the start.

How can this be done?

- A Reference Tool detailing all the necessary search and confirmation requirements.
- The Reference Tool should be available in different mediums
- An electronic tool that is easy to access for all MS Law Enforcement practitioners.
- An electronic tool that could be interactive and non-interactive
- The connection to the web site and data captured and sent via the App should be secure.

What is ERIC?

- Supported by the Criminal Justice Programme of the European Union
- 'ERIC' is a Web based product that ACRO are developing for on both desk top and mobile devices.
- An 'App' is being developed in Windows 8.1 for mobile device download.
- The Web & mobile App will have the flexibility to be populated and transmit, or just be a static information page.
- The Reference Tool information pages can be printed from the Web App.





Ask ERIC!



- The Reference Tool will list all the key criteria for each MS individually.
 These are the ECRIS mandatory requirements
- Plus other necessary information requirements unique to each MS





How ERIC can help ECRIS?

- Supported by the Criminal Justice Programme of the European Union
- The requirements will be listed in the language of the requestor and the language of the Subject
- It can demonstrate the required format of the captured data.
- It will have help fields to assist the requestor with specific information and guidance in capturing data.
- It will have a hyperlink to PRADO.

What do we need from you?

- Supported by the Criminal Justice Programme of the European Union
- A template of requirements sent to each MS
- Confirmation of the additional essential requirements your CA needs to carry out a successful search.
- Confirm the 'Useful' information requirements. These are those that would be nice to have but not essential to carry out a search or confirm identity.
- Translation of all relevant text in your country's language.





What do we need from you?

- Confirmation of the how your country records specific details e.g. a person's gender or sex. How is a sex change or transgender accounted for?
- What are the special rules for particular criteria e.g. a particular town, state or married female.
- How does your country record your nationals who are not born in your country.
- How does your country record Foreign nationals who are now legally resident in your country.

How will users access ERIC? Supported to the Europ

- Supported by ne Criminal Justice Programme f the European Union
- ERIC will be hosted and available via the ACRO web site.
- Access to the web site can be managed in a variety of ways, VPN, IP address etc.
- MS can choose a preferred access route.
- There will also be a static 'aid memoire' version via a simple login process.
